**INSTRUCTIONS FOR OWNERSHIP**

**AUTHORIZATIONS:** Farm names, corporation, organizational names will be accepted, but an "AUTHORIZATION" (separate form) is available from UIHC and must be completed and returned to the UIHC before the transfer is completed.

**MULTIPLE OWNERS:** "and" ownerships will require signatures of all parties for future transfer.

"or" ownerships require only one signature for future transfers.

Joint ownerships must be recorded in either an "and" or "or" form of ownership

**OWNERSHIP CHANGE:** Any change in the form of an ownership after a horse has been recorded in that ownership, will constitute an additional transfer and require payment of an additional transfer fee.

**FEES:** Consult a current fee schedule for applicable transfer fees. If a contract sale is involved, the BEGINNING DATE OF CONTRACT will be used as the recorded transfer date.
